Description

INVITATION TO BID FOR
CONCRETING OF LOCAL ACCESS ROAD AT BRGY. CAWAYNAN, TINAMBAC, CAMARINES SUR

1. The Local Government Unit of Tinambac, through Municipal Development Fund (MDF) – F/Y 2025 intends to apply the total sum of Four Hundred Ninety Nine Thousand Nine Hundred Seventy Seven Pesos & Nineteen Centavos (P499,977.19) only being the Approved Budget for the Contract (ABC) to payments under the contract Supply of Labor and Materials for the Concreting of Local Access Road at Bgy. Cawaynan, Tinambac, Camarines Sur, with Project Identification Number B-25P-20. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Tinambac now invites bids for the above Procurement Project. Completion of the Works is required by Jan. 31, 2026. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009.
4. Interested Bidders may obtain further information from Bids and Awards Committee (BAC) Office of LGU Tinambac, Camarines Sur and inspect the Bidding Documents at the address given below during Office Hours, from 8:00 AM – 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on Nov. 25 to Dec. 2, 2025 from given address and website/s below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand (Php.1,000.00) Pesos only. Entity shall allow the bidder to present its proof of payment for the fees in person.

6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before Dec. 2, 2025, 9:00 a.m. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
8. Bid opening shall be on Dec. 2, 2025, 9:30 a.m. at Bids and Awards Committee (BAC) Office, Department of Trade and Industry (DTI) Building, Binalay, Tinambac, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
9. The participating bidders should submit Three (3) sets of bid proposal/documents [One (1) set original copy plus Two (2) sets photo copy].
10. The Local Government Unit of Tinambac reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 12009, without thereby incurring any liability to the affected bidder or bidders.
