The Local Government Unit of Tinambac, through Municipal Development Fund (MDF) – F/Y 2025 intends to apply the total sum of One Million Four Hundred Ninety Nine Thousand Nine Hundred Ninety Six Pesos & Sixty Nine Centavos (₱ 1,499,996.69) only being the Approved Budget for the Contract (ABC) to payments under the contract Supply of Labor and Materials for the Installation/ Improvement of Street Lighting System at Bgy. Olag Pequeño, & Bgy. Tamban, Tinambac, Camarines Sur, with Project Identification Number B-25P-27. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Tinambac now invites bids for the above Procurement Project. Completion of the Works is required by Feb. 20, 2026. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009.

8. Bid opening shall be on Dec. 4, 2025, 9:30 a.m. at Bids and Awards Committee (BAC) Office, Department of Trade and Industry Building, Municipal Compound, Binalay, Tinambac, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
