The Local Government Unit of Tinambac, through Municipal Development Fund – (MDF) F/Y 2025 intends to apply the total sum of Four Hundred Ninety Nine Thousand Nine Hundred Ninety Six Pesos & Eighty Eight Centavos (₱ 499,996.88) only being the Approved Budget for the Contract (ABC) to payments under the contract Construction/Improvement of Drainage System at (Zarcedo st. Section, Bgy. San Pascual, Tinambac, Camarines Sur, with Project Identification Number B-25P-28. Bids received in excess of the ABC shall be automatically rejected at bid opening.

8. Bid opening shall be on Dec. 4, 2025, 10:00 a.m. at Bids and Awards Committee (BAC) Office, Department of Trade and Industry (DTI) Building, Binalay, Tinambac, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

9. The participating bidders should submit Three (3) sets of bid proposal/documents [One (1) set original copy plus Two (2) sets photo copy].

The Local Government Unit of Tinambac reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 12009, without thereby incurring any liability to the affected bidder or bidders.
