1. The Local Government Unit of Tinambac, through Calamity Fund – F/Y 2025 intends to apply the total sum of Five Million Nine Hundred Sixty Six Thousand Seven Hundred Fifty (₱ 5,966,750.00) Pesos Only being the Approved Budget for the Contract (ABC) to payments under the contract Construction Materials " G.I Sheet and Umbrella Nail" for distribution due to calamity. Bids received in excess of the ABC in any of the projects shall be automatically rejected at bid opening.

The Local Government Unit of Tinambac, through the Calamity Fund – F/Y 2025 intends to apply the sum of Five Million Nine Hundred Sixty Six Thousand Seven Hundred Fifty (₱ 5,966,750.00) Pesos Only for the project with Project Identification/ Solicitation Number B-23-110 being the ABC to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Local Government Unit of Tinambac now invites bids for the above Procurement Project. Delivery of the Goods is required by Jan. 16 to 30, 2025. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from Bids and Awards Committee (BAC) Office of LGU Tinambac, Camarines Sur and inspect the Bidding Documents at the address given below during Office Hours, from 8:00 AM – 5:00 PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on Dec. 18, to 29, 2025 from the given address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand (Php.5,000.00) Pesos only.

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before Dec. 29, 2025, 9:00 a.m. Late bids shall not be accepted.

7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

8. Bid opening shall be on Dec. 29, 2025, 9:30 a.m. at Bids and Awards Committee (BAC) Office, Department of Trade and Industry (DTI) Building, Binalay, Tinambac, Camarines Sur . Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

9. The Local Government Unit of Tinambac reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
